

Candidate Biographies



First Selectman

Lynn Mellis Worthington (D) has lived in Kent for 33 years. She worked for the Kent GTD for five years and a series of different area newspapers, including two different stints at the Republican American, covering Kent. She also worked full-time at South Kent School for 26 years in a variety of roles, including as an academic administrator, college counseling director, faculty member, former Publications Director, Director of Technology and Dean of Faculty. She is also an adjunct professor with Syracuse University, teaching a creative non-fiction writing course.

Long an active volunteer in Kent, Lynn served with the Kent Volunteer Fire Department for 21 years in various capacities, many times chairing committees, and was instrumental in setting up and documenting the department's policies and establishing the Standard Operating Procedures (SOPs). She was a volunteer soccer coach, Girl Scout leader and town coordinator, church school teacher and officer with Kent Pony Club. She was a trustee of the Kent Historical Society for five years and served as KHS president for two years. Lynn is currently a member of the Board of Directors for the Merwinsville Hotel Restoration, Inc., a nonprofit in Gaylordsville. Married to John Worthington, they have two adult daughters, Cassandra, 29, who lives in Maryland and Trish, 24, who lives in Rhode Island. Lynn's parents, Robert and Jo Mellis, live in Templeton Farm Apartments.

Martin Lindenmeyer (Petitioning Candidate, U) "Marty" spent over 34 years serving as a Senior Intelligence Officer with the Defense Intelligence Agency and as an Intelligence Officer with the US Navy (Retiring as Captain) specializing in intelligence support to combating terrorism, counter insurgency operations, and strategic planning. His assignments have included counterterrorism operations in Israel, the Middle East, Europe, North Africa, and Asia as well as counter-drug/counter insurgency operations in Central and South America. He also served as the Senior Intelligence Officer at the US Special Operations Command Washington Office in the Pentagon, where he routinely briefed and conducted strategic planning with members of Congress, senior White House, and National Security Staff. His travels have taken him to over 100 countries where he has participated in US, NATO, UN, and other Allied missions including humanitarian and peacekeeping operations.

He has been a lecturer on Homeland Security with the Justice and Law Administration program at Western Connecticut State University (WCSU) and currently is an Adjunct Professor teaching Geopolitical Strategies in the Master of Science in Homeland Security program at WCSU. Marty previously served as lecturer and subject matter expert on counterterrorism operations and international security policy issues at the US Naval Academy, Naval War College, Defense Intelligence College, Minister of Defense in the United Kingdom, Brooklyn Law School, University of Arizona as well as DePaul University.

Since retiring to Kent, CT in 2014, Marty has coached baseball and soccer at Kent Center School, served as Chairman of the KCS Board of Education, President of the Kent Lions Club, Commander of the American Legion Post 153 in Kent, and as a Trustee with the local Catholic Parish. Marty lives with his wife Kathleen, a Kent native and retired Navy Captain and current Director of the Career Success Center at WCSU, in Kent, CT

Rufus de Rham (Petitioning Candidate, U) has a lifetime relationship with Kent. His grandmother, Katherine Evarts, ran Cobble Hill Farm for many decades and, as a single mother of five and a farmer, she found time to sit on the Board of Ed, support the library, fund raise for Child Welfare, and serve four terms as the district representative in Hartford in the 1950s and 1960s. She was his mentor and got him involved when she pushed him to fill a vacancy on P&Z. Since then, he has served on P&Z, the Zoning Board of Appeals, 11 years on the Board of Finance (3 as Chair), a term as selectman in the 1990s, has been a member of the Board of Assessment Appeals for many years and is currently serving a term as selectman.

Rufus taught high school for 30 years, and ran the adult softball program in New Milford for 20 plus years. He was president of the New Milford Homeless Shelter Coalition from 2013 until COVID closed it down, and is a past President of the Kent Lions Club, he also coached youth soccer in Kent, and girls' tennis at HVRHS.

He has been a member of the Kent Volunteer Fire Dept. since 1978, an active EMT for 30 years and ambulance chief for three years. During his time as Ambulance Chief, the KVFD upgraded its designation from basic to advanced ambulance service. He also served on the state committee to write questions for the EMT exams. Since retiring from teaching, he has worked at the New Milford Senior Center as its Chore Services Coordinator.

Selectman

Completing his first term as Selectman, Glenn is a member of the ARPA Assessment Committee, the Swift House Task Force, and the Main Street Noise and Traffic Subcommittee. As a member of the Kent Democratic Town Committee, he has helped raise money at local events, knocked on doors for candidates, and met other Democrats in all levels of Connecticut government.

Board of Finance:

Fran Goodsell (D) Fran, who's lived in North Kent for 25 years, had a professional career as a school psychologist in Region 1 and still consults for the Region, as well as teaching online for the University of Florida. A current member of the BOF, Fran is also an active volunteer for the Kent Thrift Shop, the KVFD Auxiliary, the Board of the Kent Community Nursery School, and the KDTC.

Charles "Casey" Cogut (D) a homeowner in Kent since 1977, retired from the law firm of Simpson Thatcher & Bartlett, LLC, where he was noted for his negotiating skills and for his ability to advise corporate boards regarding governance issues and fiduciary responsibilities. Matthew Winter (Petitioning Candidate, U) is the current Chair of the Planning and Zoning Commission and has served on the Commission almost continuously since 2009. During this time, he has participated in two rewritings of the Town Plan of Conservation and Development, the rewrite of the Town Zoning Regulations, and many edits to individual sections of those Regulations.
